All that piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, on Paris Mountain Avenue between Belmont Avenue and Newland Avenue, in that section known as Sans Souci, about two miles north of the city of Greenville, being known and designated as Lot No. 32 on plat of said property recorded in the R. M. C. Office for Greenville County in plat book "B" at page 33, and having the following lines, courses and distances:
