: EXTENSION AGREEMENT  
COUNTY OF GREENVILLE )

WHEREAS, on the first day of December, 1954, G. J. Hughes and Ann C. Hughes executed a note in the sum of Twelve Thousand and No/100 (\$12,000.00) Dollars to the First Federal Savings and Loan Association of Greenville, to be repaid in monthly instalments of One Hundred, Eight and 01/100 - (\$108.01) Dollars, with interest thereon at the rate of four and one-half (4-1/2%) per centum per annum, to be computed monthly, and

WHEREAS, at the same time a mortgage was executed by the said G. J. Hughes, covering Lot "B" on East Faris Road as shown by plat recorded in the R. M. C. office for Greenville County in Plat Book CC, at page 6, and

WHEREAS, it is now desired that the payments in the aforesaid note and mortgage be reduced to the amount of Seventy-Five and 92/100 - (\$75.92) Dollars per month, with interest rate to continue at the rate of four and one-half (4-1/2%) per centum per annum.

NOW, THEREFORE, in consideration of the premises above mentioned, it is agreed by First Federal Savings and Loan Association of Greenville, and accepted by G. J. Hughes that the payments as set out in the aforesaid note and mortgage be reduced from One Hundred, Eight and 01/100 - (\$108.01) Dollars per month to the monthly payment of Seventy-Five and 92/100 - (\$75.92) Dollars, and the said G. J. Hughes agrees to make said payments according to this Extension Agreement for said amount.
