All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being at the southerly corner of the intersection of Laurens Road and South Pleasantburg Drive (S. C. By-Pass No. 291), in the City of Greenville, S. C., and having according to a plat entitled Property of James W. Curdts, Trustee, dated November 19, 1952, prepared by Dalton & Neves, the following metes and bounds, to-wit:
