C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor. in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, , lying on the north side of the old Buncombe Road.

BEGINNING on a point in the said road on the Clayton Corner; thence with the Clayton line 175 feet to a pin on said line, thence parallel with the above said road 150 ft. to a pin; thence parallel with the Clayton line 175 feet to a point in the above said road; thence with the center of said road 150 feet to the beginning corner. Containing 1.00 acre more or less. The above described land is a portion of the same land known as the old Fowler land.
