WHEREAS, the Mortgagor is well and truly indebted unto

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Hundred and No/100 - - -

> DOLLARS (\$ 200.00),

with interest thereon from date at the rate of repaid:

per centum per annum, said principal and interest to be six

\$25.00 on August 1st, 1956, and \$25.00 on the 1st day of each month thereafter until paid in full; payments to be applied first to interest, balance to principal, with interest thereon from date at the rate of six per cent, per annum, to be computed and paid monthly, until paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, containing 7.5 acres, and having, according to Plat by J. C. Hill dated March 7, 1955, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the Northern line of the 45 acre tract owned by Mattie Dial Free and the Mortgagor, which pin is 611.5 feet from the Northwestern corner of said tract, and running thence with the line of property of Mattie Dial Free, S. 7-45 W. 265 feet to an iron pin; thence continuing with the line of Mattie Dial Free property, S. 82-15 E. 950 feet to an iron pin on branch; thence with the branch as the line, N. 17_30 E. 420 feet to iron pin at old rock dam; thence S. 88-40 W. 858 feet to an iron pin; thence N. 82-15 W. 182 feet to an iron pin, the point of beginning.

It is understood that this Mortgage is second and junior in lien to Mortgage held by Fidelity Federal Savings & Loan Association covering the above described property recorded in the R.M.C. Office for Greenville County in Mortgage Book 660, at page 307.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
