"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Chick Springs Township, being known and designated as Lot No. 23 on a Plat of a Subdivision of Talmer Cordell made by Dalton & Neves, April 1951, recorded in the R.M.C. Office for Greenville County in Plat Book AA, at page 33, and having the following metes and bounds:
