NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, on the east side of a county road leading from the Rutherford Road near the farm of J.D. DIII, about 3 miles northwestward from the City of Greer, and being Lots Nos. 65, 66 and 67 of the I.D. Bishop Property, survey and plat by H.S. Brockman, Surveyor, dated July 20, 1948, and having the following courses and distances, to wit:

BEGINNING at the intersection of two county roads, and running thence along one of the same N. 75.45 E. 300 feet; thence S. 6.20 E. 214 feet to corner of Lot No. 68; thence along line of same S. 88.51 W. 245 feet to county road; thence along said road N. 24.30 W. 164.5 feet to the beginning corner.
