"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the south side of Ashmore Street and designed as Lot No. 19 on plat of the J.D. Ashmore Property, prepared for
