C., does hereby authorize the mortgagor, Brown, Inc., a corporation, to make payments on the aforesaid mortgage, which is recorded in the R. M. C. Office for Greenville County in Mortgage Book 675, at page 83, at the rate of Forty Eight and 53/100 (\$48.53) Dollars per month, and that so long as said payments are made promptly on the first day of each and every calendar month this loan shall not be considered delinquent, but shall the mortgagor herein fail to make said payments as agreed, then, in that event, the holder of this mortgage may institute foreclosure proceedings without further delay according to the terms as set out in said note and mortgage.
