

MORTGAGE OF REAL ESTATE.

To All Whom These Presents May Concern: .

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Eleven Thousand, One Hundred and No/100 - - - - -

(\$ 11,100.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being known and designated as Lots 32 and 33 on plat of Casa Loma Estates made by Piedmont Engineering Service in October 1947, recorded in the R.M.C. office for Greenville County in Plat Book S, at page 65, and having, according to said plat, the following metes and bounds, courses and distances, to-wit:

"BEGINNING at an iron pin on the east side of Courtney Circle, the joint front corner of Lots Nos. 31 and 32, and running thence with the line of Lot 31, N. 70-26 E. 180 feet to an iron pin; thence N. 19-34 W. 160 feet to an iron pin; thence with the line of Lot No. 34, S. 70-26 W. 180 feet to an iron pin on the east side of Courtney Circle; thence with the east side of Courtney Circle, S. 19-34 E. 160 feet to the beginning corner; being the same conveyed to me by J. W. Cannon, Inc. by deed not yet recorded."
