C. Jones, Associates, dated February, 29, 1956, and recorded in the R.M.C. Office for Greenville County in Plat Book EE at page 180, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Sevier Court at its intersection with Bahan Street and running thence S. 45-34 W. 27.7 feet in said intersection, to an iron pin on the Eastern side of Bahan Street; thence along Bahan Street, S. 0-42 E. 45 feet to an iron pin, the joint front corner of Lots Nos. 9 and 10, as shown on said plat; thence S. 88-10 E. 121.1 feet to an iron pin, the joint rear corner of Lots Nos. 9 and 10; thence N. 1-50 E. 65 feet to an iron pin on the Southern side of Sevier Court; thence with the Southern side of Sevier Court, N. 88-10 W. 104.2 feet to an iron pin, the point of beginning.
