"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs, Township, located on the southwest side of Mimosa Drive, formerly Greer Mill Road, in the City of Greer, having the following courses and distances:

BEGINNING on an iron pin on the southwest side of Mimosa Drive, corner of lot now or formerly owned by Clyde Smith, and runs thence with the line of that lot, S. 49.10 W. 220 feet to an iron pin, joint corner of the Smith lot and on line of property formerly owned by Haynsworth and Burgess, now Bennett; thence with said line, S. 43.15 E. 130 feet to an iron pin, corner of M.H.
