State, at Chambers or otherwise, for the ampdintment of a Bracker, with authority to take charge of the mortgaged premises, designate a reasonable rental, and callest faint and apply the net proceeds thereof (after paying cost of collection) upon said debt, interest, taxes and are insurance, without liability to account for anything more than the rents and profits actually collected.
