"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the western side of Maple Street near the City of Greenville, known and designated as Lot No. 9 Block A, plat of Washington Heights, recorded in Plat Book M at Page 107, according to said plat being more particularly described as follows:

"BEGINNING at an iron pin on the western side of Maple Street front corner of Lot No. 10 which point is 147 feet N. 27-24 W. from the northwestern intersection of Maple Street and Washington Loop and running thence with the line of Lot 10 S. 65-57 W. 216 feet to an iron pin; thence N. 21-45 W. 40 feet to an iron pin rear corner of Lot 8; thence with the line of said lot N. 65-57 E. 202 feet to an iron pin on the western side of Maple Street; thence with the western side of said street S. 27-24 E. 40 feet to the beginning corner."
