

C., in the full and just sum of (\$2400.00 Twenty-four Hundred & no/100 -) Dollars, per cent (7 %) per annum, unpaid interest to

(\$38.40) dollars Thirty-eight & 40/100 due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile from the City of Greer, designated as Lots Nos. 54 and 55 of Pleasant Heights Development, according to survey and a plat of a sub-division for R. A. Dobson & I. B. Dobson, said plat made by H. L. Dunahoo, Surveyor, dated September 4, 1950, and having the following distances:

Lots Nos. 54 and 55: BEGINNING at a stake at the intersection of the New Pelham Road and Bailey Avenue, and running thence along the New Pelham Road, N 16.00 W. 200 feet to corner of lot No. 56; thence along the line of Lot No. 56, N 84.30 W. 212 feet to stake, corner of lot no. 53; thence along the line of Lot No. 53, S 16.00 E. 241 feet to stake on Bailey Avenue; thence along said avenue, N 84.00 E. 200 feet to the beginning corner.
