

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwest side of Sedgefield Drive, near the City of Greenville, shown as Lot 22 on plat of Section III of Timberlake Subdivision made by Dalton & Neves, Engineers, May, 1956, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book EE, page 4, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwest side of Sedgefield Drive, at joint front corner of Lots 21 and 22; thence with the line of Lot 21, S. 53-19 W. 203.1 feet to an iron pin; thence S. 1-06 W. 79.7 feet to an iron pin; thence with the line of Lot 23, N. 63-28 E. 246.6 feet to an iron pin on the southwest side of Sedgefield Drive; thence with the curve of Sedgefield Drive (the chord being N. 31-43 W. 107 feet) to the beginning corner; being the same conveyed to me by S. W. Creech as Trustee by deed of even date herewith, not yet recorded."
