NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lot #277, on plat of the property of Robert J. Edwards, recorded in Plat Book EE at Page 61, in the R.M.C. Office for Greenville County and described as follows:

"BEGINNING at an iron pin on the Northwest side of Barbara Avenue, at the joint corner of lots #277 and 278, and running thence with the line of lot #278, N. 47-0 W. 300 feet to an iron pin; thence S. 43-0 W. 100 feet to an iron pin, joint rear corner of lots #276 and 277; thence with the line of lot #276, S. 47-0 E. 300 feet to an iron pin on Barbara Avenue; thence with Barbara Avenue, N. 43-0 E. 100 feet to the beginning corner."
