To ALL WHOM THESE PRESENTS MAY CONCERN:

G. David McGill of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

C. Douglas Wilson & Co., a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Nine Hundred and no/100-Dollars (\$ 11, 900. 00 ), with interest from date at the rate of five per centum ( 5 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-Nine and 62/100-----Dollars (\$ 69. 62 ), commencing on the first day of August, 19 57, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of July, 19 82.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: in the City of Greenville, S. C. on the western side of Summit Drive (formerly Bennet Street) and being known and designated as Lot No. 3, Block 1, Section A of Parkvale as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book 'K', at Page 52 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Summit Drive, joint front corner of Lots Nos. 2 and 3 and running thence along the joint side line of said lots N. 74-45 W. 155 feet to an iron pin; thence N. 40-0 E. 52 feet to an iron pin, joint rear corner of Lots Nos. 3 and 4; thence along the joint side line of said lots S. 88-25 E. 147.9 feet to an iron pin on the western side of Summit Drive; thence along said Summit Drive S. 22-40 W. 82.3 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the
