We, Milton Switzer and Mildred Collins Switzer

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and No/100- - - - -

DOLLARS (\$ 10,000.00), with interest thereon from date at the rate of Five & One-Half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

^{those three} "All ~~some~~ certain piece^s/parcel^s or lot^s of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Mountain View Avenue, being shown as lots # 27, 28, and 29, on plat of North Park, recorded in Plat Book K at Pages 48 and 49, and when described together have the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northern side of Mountain View Avenue, at the rear corner of lot # 5, and running thence with the rear line of lots # 5 to 1 inclusive, N. 19-45 E. 312 feet to an iron pin; thence N. 66-30 W. 343.5 feet to an iron pin; thence S. 7-35 W. 154.1 feet to pin; thence S. 5-33 W. 117.5 feet to iron pin on Mountain View Avenue; thence with the Northern side of Mountain View Avenue, S. 68-20 E. 266.2 feet to the point of beginning. "
