All that piece, parcel or lot of land situate, lying and being State and County aforesaid, Chick Springs Township, about three miles southwest of Greer, on the West side of the Gibbs Shoals Road, having the following courses and distances, to wit:

BEGINNING on a nail and cap in the center of the said Gibbs Shoals Road at the intersection of a dirt road and which is the joint corner of my home place, and runs thence with the said road, N. 3-12 E. 278 feet to a nail and cap in the center of the said road; thence a new line, S. 88-56 W. 322 feet to a stake or iron pin; thence S. 0-26 E. 341 feet to a nail and cap in the center of the dirt road, at a point 11.3 feet from a light post; thence with the dirt road, N. 77-10 E. 3&1.7 feet to the beginning corner, containing Two and Twenty Two One-hundredths (2.22) acres more or less.
