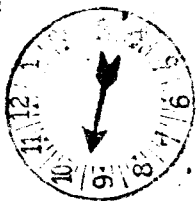

SEND GREETING:

Whereas, I, the said Estella Goldsmith
in and by my certain promissory note in writing, of even date with these
Presents, am well and truly indebted to FarmersBank of Simpsonville
in the full and just sum of Three Hundred Eighty Six and No/100 --Dollars
, to be paid \$20.00 one month after date hereof and a
like payment on each succeeding month thereafter until paid in full.

, with interest thereon from date
at the rate of 6 per centum per annum, to be computed and paid in advance
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Farmers Bank of Simpsonville, its successors or assigns:

All that piece, parcel or lot of land in Fairview Township,
Greenville County, State of South Carolina, being designated as tract
No. 1 of the T. M. Goldsmith Estate as shown on a plat recorded in
Plat Book EE at page 127 in Office of the R. M. C. for Greenville
County, and having the following courses and distances:

BEGINNING at a point in center old county road on old T. M.
Goldsmith and Lockheart line and running N. 22-40 W., 24.5 ft. to iron
pin at Sycamore tree; thence N. 22-59 W. 80.6 ft to iron pin on bank
of Spring Branch; thence down meandering of said branch, as line,
N. 29-19 W. 445.8 ft. to iron pin at bend in Branch; thence S. 78-19
W. 244.7 ft. to bend in said branch; thence N. 41.19 W. 111.3 ft. to
confluence of waters of said branch and Rocky Creek; thence up the
meanderings of Rocky Creek, as line, N. 25-15 E., 63.5 ft. to stk.;
thence N. 41.22 E. 111.3 ft. to bend in said creek; thence N. 1-45
E. 132.7 ft. to bend; thence N. 48-20 E. 86.5 ft. bend in said
Creek; thence, continueing up meanderings of Rocky Creek, as line,
