WHEREAS, the said Mortgagor in and by certain promissory note in writing, of even date with well and truly indebted to BANK OF GREER, GREER, S. C., hereinafter called am Mortgagee, in the full and just sum of Thirty seven hundred - - -

NOW KNOW ALL MEN, That the said Mortgagor , in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that certain parcel or tract of land containing Twenty-seven an one half Acres, more or less, situated near Lenoah School in Highland Township, Greenville County, State of South Carolina, bounded by lands now or formerly belonging to W.W. Davis Estate, R.E. Odom Estate, B.A. Jenkins and others, and being the same property conveyed to A. Roy Jenkins by deed of Eugene H. Davis, recorded in Deed Book 234, page 82, R.M.C. Office for Greenville County.

ALSO, all that other certain parcel or lot of land containing Five (5) acres, more or less, situated near the tract above described, near Lenoah School, in Highland Township, County and State afores aid, having the following courses and distances, to wit: Beginning at the intersection of the Gap Greek Road, now State Highway No. 101, and the highway leading by the Blind Tyger Bridge toward Mt. View, and running thence along said Gap Creek Road in a southern direction approximately 12 chains to an iron gin; thence N. 76.34 W. 9.57 chs. to a stone; thence N. 27.50 W. 2.27 chains to a pin in the highway, commonly referred to as the Blind Tyger Bridge Road; thence along said road or highway approximatel 12.00 chains to the beginning corner.
