

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or tract of land lying and being in Gantt Township, Greenville County, State of South Carolina, being known and designated as lot No. 50 on a plat thereof of "Conestee, S. C.", recorded in Plat Book K, page 276, and being the same lot conveyed to John Gresham by Frank J. Fowler by deed dated March 11, 1949, recorded in Deed Book 375, page 386, and being likewise the same parcel of land this day conveyed by John Gresham to Albert Moore and Dora Moore. It is located on the southern side of Third Avenue with a frontage thereon of 68 feet and runs back in parallel lines 192 feet and is bounded on the north by Third Avenue, on the east by lots 52 and 51 on the mentioned plat, on the south by lot No. 49 on the said plat and on the west by lot Nos 34 and 33 on the plat.
