"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the South side of Blue Ridge Drive (formerly Arlington Avenue) near the City of Greenville, being shown as Lot No. 2 on a revised plat of the property of B. E. Geer, prepared by W. M. Rast, dated February, 1929, recorded in Plat Book H at page 142, and according to said plat being more particularly described as follows:
