All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, lying on the south side of Bual-lane Highway U S. 29 and on the eastern side of North Main St. and on the north side of an unnamed street and being a part of lot # 1 as shown on a plat of the property of J.C. Moon made by H.S. Brockman and dated June 12, 1947 the same being recorded in Plat Book Page, (Note; N. Main Street was widened, accounting for the difference in this description and that on the above referred to plat) and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the SE corner of the intersection of W.S. 29 and N. Main St., said iron pin being on the southern edge of the right-of-way of U.S. 29 and on the eastern edge of the right-of-way of N. Main St. and running thence along the eastern edge of N. Main St. S. 12.56 E. forty two (42) feet to an iron pin at the NE corner of the intersection of N. Main St. and an unaamed street; thence with the northern edge of said unnamed st. S. 82-52 E. 115.1 feet to an iron pin, joint corner lots 1 and 2; thence as the dividing line between lot 1 and lot 2, N. 4-50 E. 44.9 feet to an iron pin on the southern edge of the right-of-way of S. 29; thence with the right-of-way of U.S. 29 N. 85-00 W. 124 feet to the beginning corner.
