1953, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of U. S. Highway No. 29 at corner of Property of S. M. Capell and running thence along the Northwest side of said highway S. 42-25 W. 208.2 feet to an iron pin on the East side of said highway in the center of a county road, thence along the center of said county road N. 52-0 W. 255.3 feet to an iron pin at corner of property of C. N. Pitmon, thence along the said Pitmon line N. 42-25 E. 340.8 feet to an iron, thence along the line of property of S. M. Capell S. 23-50 E. 278.6 feet to an iron pin on the Northwest edge of U. S. Highway No. 29, the beginning corner.

The lot first above described is all of the property belonging to the Grove Baptist Church on the East side of U. S. Highway No. 29, on which the Church, Sunday School and Educational Building are located. TO HAVE AND TO HOLD all and singular the said Premises unto the said mortgagee(s) its AMM, successors and Assigns. And W^L do hereby bind Ourselves, and Our Main Successors, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said mortgagee(s) heirs, successors and Assigns, from and against the mortgagor(s), their Main Successors, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
