sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its

ALL that piece, parcel or lot of land situate, lying and being on the
eastern side of Edwards Road, near the City of Greenville, County of
Greenville, State of South Carolina, and known and designated as Lot
