NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the southwestern side of Sunset Drive in the City of Greenville, being shown as Lot No. 34 on plat of Knollwood, recorded in Plat Book EE, Page 35, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin in the south side of Sunset Drive in the joint front corner of Lots 33 and 34 and running thence with Sunset Drive S. 64-31 E. 69.9 feet to an iron pin; thence continuing with the curve of Sunset Drive in an easterly direction 20.2 feet to an iron pin corner of Lot 35; thence with the line of said lot S. 25-29 W. 157.8 feet to an iron pin; thence N. 70-17 W. 90.5 feet to an iron pin rear corner of Lot 33; thence with the line of said lot N. 25-29 E. 165 feet to the point of beginning.
