

All that lot of land in Austin Township, Greenville County, State of South Carolina in the Town of Simpsonville on the south side of North Pliney Circle, known and designated as lot No. 69 of the subdivision known as League Estates, according to a plat made by W. J. Riddle Surveyor in October 1941 and recorded in the R. M. C. Office for GreenvilleCounty in Plat Book K at pages 111 and 112, and having according to aid plat the following metes and bounds, to wit:

BEGINNING at a pin on the south side of North Pliney Circle at the North-east corner of lot No. 70 and running thence along the southern side of said Circle, N. 70-15 E. 116.5 feet to corner of lot 68; thence with the line of lot 68 S. 19-45 E. 200 feet to corner of lots nos 43 and 42; thence with the line of lot no. 42 3. 70-15 W. 98 feet to a pin in rear line of lot no. 5; thence with the rear line of lots 5, 6 and 70, N. 25-0 W. 201.8 feet to the beginning corner and being the same property conveyed to mortggor by deed recorded in deed book 398 at page 411 in the Greenville County R.
