BEGINNING at an iron pin on the Northern side of Forestdale Drive at the joint front corner Lots Nos. 24 and 25 and running thence with the line of Lot No. 24, N. 4-31 E. 200 feet to an iron pin the joint rear corner of Lots Nos. 24 and 25; thence with the rear line of Lot No. 25, S. 85-29 E. 70 feet to an iron pin the joint rear corner of Lots Nos. 25 and 26; thence with the joint line of said lots, S. 4-31 W. 200 feet to an iron pin on the Northern side of Forestdale Drive, the joint front corner Lots Nos. 24 and 25; thence with the Northern side of said drive, N. 85-29 W. 70 feet to the point of beginning.

LOT NO. 26:

BEGINNING at an iron pin on the Northern side of Forestdale Drive at the joint front corner Lots Nos. 25 and 26 and running thence with the line of Lot No. 25, N. 4-31 E. 200 feet to an iron pin the joint rear corner of Lots Nos. 25 and 26; thence with the rear line of Lot No. 26, S. 85-29 E. 70 feet to an iron pin the joint rear corner of Lots Nos. 26 and 27; thence with the joint line of said lots, S. 4-31 W. 200 feet to an iron pin on the Northern side of Forestdale Drive, the joint front corner Lots Nos. 25 and 26; thence with the Northern side of said drive, N. 85-29 W. 70 feet to the point of beginning.
