Beginning at a point in the center of the said road, corner of C. Barnett property and runs thence S. 42-45 E., 531.5 feet along the Southern side of a strip reserved for a road right of way; thence N. 36-25 E., 554 feet along the Edwards property to a white oak; thence N. 1-20 E., 661 feet; thence N. 80-45 E., 431 feet to a point; thence N. 71-45 E., 668 feet across branch to a point on C.
