"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

near the City of Greenville, on the Northwestern corner of Hearthstone Lane and Botany Road, being shown as Lot No. 72 on Plat of Sector II of Botany Woods recorded in Plat Book QQ, at page 79, and described as follows:

BEGINNING at an iron pin at the Northwestern corner of Botany Road and Hearthstone Lane, and running thence with the Western side of Botany Road, N. 11-05 W. 130 feet to stake at corner or Lot No. 71; thence with the line of said lot, S. 80-40 W. 185 feet to stake in line of Lot No. 74; thence with the line of Lots Nos. 74 and 73, S. 14-02 E. 164.2 feet to iron pin on Hearthstone Lane; thence with the Northern side of said Lane, N. 77-50 E. 151.3 feet to iron pin at corner of Botany Road; thence with the curve of the intersection with Botany Road, the chord of which is N. 33-23 E. 35.6 feet to the beginning corner.
