"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the eastern side of Piney Road, being shown as Lot No. 13 on plat of Piney Mountain Park, recorded in Plat Book E at Page 201, and having the following metes and bounds, to-wit:
