Pl3.5 feet to an iron pin the joint rear corner Lots Nos, 29 and 30; thence along the joint line of said lots; N. 59-12 W. 166.5 feet to an iron pin on the southeastern side of said Monterey Lane joint front corner Lots Nos. 29 and 30; thence with the curvature of the northeastern side of said Monterey Lane, the chord of which is N. 29-20 E. 82 feet to the point of beginning.
