"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being shown as Lot 33, Section C, on a plat of the property of Stone Land Company, recorded in Plat Book A at pages 337 to 345, R. M. C Office for Greenville County, and having according to said plat the following metes and bounds:
