"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate at the south—castern corner of Isaac Lane and Chipwood Lane, in Butler Township, being shown and designated as Lot No. 36 on plat of Green Hills, recorded in Plat Book HH at Page 189, and having according to said plat the following metes and bounds, to-wit:
