TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are defend all and singular the premises unto the Mortgagor further covenants to warrant and forever whomsoever lawfully claiming the same or any part thereof.

- 4. That he will keep all improvements now existing or hereafter erected upon the mortgaged property in good are necessary, and charge the expenses for such repairs to the mortgage debt.
- 5. That the Mortgagee may require the maker, co-maker or endorser of any indebtedness secured hereby to carry life insurance upon himself in a sum sufficient to pay all sums secured by this mortgage, designating the Mortgage as beneficiary thereof, and, upon failure of the Mortgagor to pay the premiums therefor, the Mortgagee may, as its option, pay said premiums, and all sums so advanced by the Mortgagee shall become a part of the mortgage debt.

That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgagee, on the first day of each month, until the indebtedness miums, as estimated by the Mortgagee, and, on the failure of the Mortgager to pay all taxes, insurance prepublic assessments, the Mortgagee may, at its option, pay said items and charge all advances therefor to the mortgage debt.

- 8. That, at the option of the Mortgagee, this mortgage shall become due and payable forthwith if the Mortgagor shall convey away said mortgaged premises, or if the title shall become vested in any other person in any manner what-oever other than by death of the Mortgagor.
- 9. It is agreed that the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall builty perform all the terms, conditions, and covenants of this mortgage, and of the note secured hereby, that any of the terms, conditions or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgage, all sums then owing by the Mortgagor to the Mortgagee shall become impediately due and payable, and should the Mortgagee become a party to any suit involving this Mortgage or the title to the premises described by suit or otherwise, all costs and expenses incurred by the Mortgagee, and a reasonable attorney's fee, shall thereupon thereby, and may be recovered and collected herefunder.
