cured hereby), said note to be repaid with interest at the rate specified therein in installments of.....

extended, will be due and payable 15 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a geriod of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, in and by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

BEGINNING at a pin on the southern side of Farr's Bridge Road at the corner of property heretofore conveyed by J. C. Hughes to Bertha T. and D. H. King, and running thence with the southern side of Farr's Bridge Road, S. 88-02 E. 38.2 feet to a pin; thence continuing with the Farr's Bridge Road, S. 85-55 E. 61.8 feet to a pin; thence S. 0-41 W. 510 feet to a pin; thence N. 29-00 W. 200 feet, more or less, to the rear corner of the King lot; thence with line of the King lot, N. 0-41 E. 350.2 feet to the point of beginning; being the same conveyed to us by J.
