To All Whom These Presents May Concern:

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Eighteen Thousand and No/100 Dollars (\$18,000.00) not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the rate specified therein in installments of

One Hundred Fifteen and 98/100 - - - - - 115.98 Dollars upon the first day of

each and every calendar month hereafter in advance, until the full principal sum with interest, has been paid such monthly payments to be applied first to the payment of interest accrued monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable 25 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection to be added to the amount due on said note and to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt or any part thereof, be collected by an attorney, or by legal process, of any kind (all of which is secured under this mortgage), as in and by said note, reference being thereto made, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand, and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, as and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold, released and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 133 of a subdivision known as Orchard Acres, Section Two, as shown on a plat of a portion of said subdivision prepared by J. Mac Richardson, Surveyor, March, 1960, and recorded in the R. M. C. office for Greenville County in Plat Book QQ, at page 6, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern edge of Ridge Spring Street, joint front corner of Lots 133 and 134, and running thence along the joint line of said lots, N. 4-14 W. 158.6 feet to an iron pin at the joint rear corner of Lots 133 and 136; thence along the joint line of Lots 134 and 135, S. 36-48 E. 408.1 feet to an iron pin on the western edge of Orchard Drive; thence along the western edge of Orchard Drive, S. 25-08 W. 52.2 feet to an iron pin; thence continuing with the western edge of Orchard Drive, S. 40-08 W. 40.1 feet to an iron pin; thence continuing with the north-western edge of Orchard Drive as it converges with Ridge Spring Street, S. 70-15 W. 40.7 feet to a concrete monument on the northern edge of Ridge Spring Street; thence along the northern edge of Ridge Spring Street, S. 25-34 W. 98.5 feet to the beginning corner, being the same conveyed to me by deed D. 3411 by dated of even date, to be recorded herewith."
