All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at Travelers Rest, S. C., shown as an unnumbered lot on plat of property of Homer Styles, recorded in the R. M. C. Office for Greenville County in plat book YY at page 49, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Paris View Drive at the rear corner of Lot 42, which iron pin is situate 200 feet west of the squared intersection of Tubbs Mountain Road, and running thence along the rear of lots 42 and 43, N 8-11 W, 200 feet to an iron pin; thence S 81-53 W, 100 feet to an iron pin; thence S 8-11 E, 200 feet to the north side of Paris View Drive; thence with said Drive, N 81-49 E, 100 feet to the point of beginning.
