We, Nina H. Simmons and Doyle W. Simmons

SEND GREETING:

WHEREAS, we the said Nina H. Simmons

in and by our certain promissory note in writing of even date with these Presents, are well

and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of

Two hundred seventy-one and 92/100 - - - (\$ 271.92) Dollars,

with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to

bear interest at the same rate, to be repaid in installments of

Fifteen and no/100 - - - (\$ 15.00) dollars

due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and, said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That we the said Nina H. Simmons and Doyle W. Simmons

in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor, in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile North from Chick Springs, lying on the East side of Turrentine Road, being all of lots Nos. 22, 23, 24, and 25 on a plat of property made for Mrs. Nellie M. Turrentine by H. S. Brookman, Surveyor, dated July 12, 1948, and having the following courses and distances:-

BEGINNING on a stake on the eastern margin of Turrentine Road, joint corner of Lots Nos. 1 and 25 on said plat, and runs thence with the common line of lot No. 25 and lot No. 1, 2 and 3 S. 40.45 E. 222.5 feet to a stake, joint corner of lots 3, 4, 10 and 25; thence N. 18.15 E. 286.1 feet to a stake, joint corner of lots nos 21, 22, 11, and 15; thence with the common line of lots nos. 21 and 22 N. 62 W. 157.2 feet to a stake on the eastern margin of Turrentine Road; thence therewith S. 28.00 W. 200 feet to the beginning corner, containing one acre, more or less.
