(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ______ Twenty-Three Thousand and No/100 ______ DOLLARS (\$ 23,000.00), with interest thereon from date at the rate of Five & Three-Fourths per centum per annum, said principal and interest to be repaid in monthly instalments of ______ One Hundred Forty-Five & No/100 Dollars (\$ 145.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgager, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgager may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina County of Greenville, in the City of Greenville, being shown as Lot 14 on plat of Stone Lake Heights, Section 3, recorded in Plat Book QQ at Page 97, and having according to said plat the following metes and bounds, towit:

"BEGINNING at an iron pin on the eastern edge of Stone Drive, at the joint front corner of Lots 13 and 14, and running thence with line of Lot 13, 8. 59-20 E. 195 feet to iron pin in center of drainage easement; thence along the line of Lot 15 and following said dranage easement for a portion of the distance N. 23-50 E. 194.2 feet to iron pin on the southern edge of Stone Lake Drive; thence along the southern edge of Stone Lake Drive, N. 71-29 W. 135 feet to iron pin; thence with the curve of Stone Lake Drive and Stone Drive, the chord of which is S. 72-50 W. 38.9 feet to iron pin on the eastern edge of Stone Drive; thence along the eastern edge of Stone Drive S. 37-12 W. 135 feet to the beginning corner."

Said premises being the same conveyed to the mortgagors by deed recorded in Deed Book 693 at Page 405.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
