"ALL that certain piece parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville, being shown as 30.6 acres on plat of property of D. b. Verdin and D. L. bramlett by C. O. kiddle, dated April, 1962, and having according to said plat, the following metes and bounds, to-wit:
