cured hereby), said note to be repaid with interest at the rate specified therein in installments of

"BEGINNING at an iron pin on the northern side of Swanson Court, the joint front corner of Lots Nos. 16 and 17, and running thence along the joint line of said lots, N: 31-04 E. 181 feet to an iron pin on the bank of Richland Creek thence continuing along the joint line of said lots, N. 31-04 E. 12 feet, more or less, to a point in the center of Richland Creek, joint rear corner of said lots; thence along the center line of Richland Creek, a traverse line being N. 57-45 W. 82.5 feet, to a point in the center of said creek, joint rear corner of Lots Nos. 17 and 18; thence along the joint line of said lots, S. 31-04 W. 15 feet, more or less, to an iron pin; thence continuing along the joint line of said lots, S. 31-04 W. 183 feet to an iron pin on the northern; side of Swanson Court; thence along the northern side of Swanson Court, S. 58-56 E. 85 feet to the beginning corner; being the same conveyed to the mortgagor corporation by J.
