Together wish all rights, privileges, interest, easements, improvements, tenements, hereditaments, and appurtenances thereunto belonging or pertaining, and all fixtures, equipment and appliances now or subsequently attached to or used in connection with said premises (all said property being herein referred to as "the premises").

TO HAVE AND TO HOLD, all and singular the said premises to Mortgagee, its successors and assigns forever.

- As further security for payment of the indebtedness and performance of the obligations,
 - cured hereby, Mortgagor does hereby transfer, set over and assign to Mortgagee:

 (a) All rents, issues and profits of the premises from time to time accruing, whether under least existing or hereafter created, reserving to Mortgagor, however, so long as Mortgagor is not in default here under, the right to receive and retain such renist, issues and profits.

 All judgments, awards of damages and settlements hereafter made resulting from condemnation proceedings.
 - or in lieu of any taking of the premises or/any part thereof under the power of eminent domain, or for any damage (whether caused by such taking or otherwise) to the premises or the improvements thereon or any part thereof, or to any rights appurtenant thereto, including any award for change of grade of streets. Mortgages is hereby authorized, but not required, on behalf and in the name of Mortgagor, to execute and deliver yalid acquite tances for, and to appeal from, any such judgments or awards. Mortgagee may apply all such sums or any part thereof so received, after the payment of all its expenses, including costs and attorneys' fees, on the indebtedness secured hereby in such manner as it elects, or, at its option, the entire amount or any part thereof so received may be released.

Mortgagor covenants and agrees with Mortgagee as follows:

- 1. Mortgagor is lawfully seized of an indefeasible estate in fee simple, free from encumbrances, has good right and er to convey the premises, and does hereby warrant and will foreyer defend all and singular the premises unto Mort gagee against Mortgagor and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.

The amount of such taxes, assessments and premiums, when unknown, shall be estimated by Mortgagee. Such deposits shall be used by Mortgagee to pay such taxes, assessments and premiums when due. Any insufficiency of such account to hav such charges when due shall be paid by Mortgagor to Mortgagee on demand. In event of enactment of any law imposing payment of all or/any portion of any such taxes upon Mortgagee, or the rendering by any court of competent jurisdiction of a decision that the undertaking by Mortgagor, as herein provided, to pay such tax or taxes is legally inoperative, then, unless Mortgagor nevertheless pays such taxes, all sums hereby secured, without any deduction, shall at the option of Mortgagee become immediately due and payable, notwithstanding anything contained herein or any law heretofore or

Mortgagor will keep the improvements now existing or hereafter erected on the premises insured as may be required from time to time by Mortgagee against loss by fire and other hazards, casualties and contingencies in such amounts and for such periods as may be required by Mortgagee and will pay promptly, when due, any premiums on such insurance. All insurance shall be carried in companies approved by Mortgagee and the policies and renewals thereof shall have attached thereto loss payable clauses in favor of and in form acceptable to Mortgagee. In event of loss Mortgagor will give immediate notice by mail to Mortgagee, who may make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to Mortgagee instead of to Mortgagor. and Mortgagee jointly. Any and all amounts received by Mortgagee under any of such policies may be applied by Mortgagee on the indebtedness secured hereby in such manner as Mortgagee may, in its sole discretion, elect or, at the option of Mortgagee, the entire amount so received or any part thereof may be released. Such insurance policies, and abstracts of title and other title evidence, shall be delivered to and held by Mortgagee. In event of foreclosure of this mortgage or other transfer of title to the premises in extinguishment of the indebtedness secured hereby, all right, title and interest of Mort-gagor in and to such insurance policies, abstracts of title and other title evidence shall become the absolute property of
