NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that čertain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and heing in the State of South Carolina, County of Greenville, being known and designated as Lot No. 24 on plat of Starsdale Manor subdivision, recorded in plat book NN page 9 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Starsdale Circle, the joint front corner of Lots Nos. 24 and 25; thence with the joint line of said lots N. 21-25 W. 145 feet to an iron pin; thence with the rear line of Lot Nos. 20 and 21, S. 68-35 W. 100 feet to a concrete monument corner of Lot No. 23; thence with the line of said lot S. 21-25 E. 145 feet to an iron pin on the north side of Starsdale Circle; thence with the north side of said Street N. 68-35 E. 100 feet to the beginning corner.

This loan is insured by the Mortgage Guaranty Insurance Corporation and it is understood and agreed that at the expiration of 10 years from the date of this mortgage, Fidelity Federal Savings and Loan Association may at its option, apply for insurance for an additional five years with Mortgage Guaranty Insurance Corporation, and the mortgagor will pay to Fidelity Federal Savings and Loan Association a premium for such insurance of 1/2 of 1% of the principal balance then existing; and this agreement and covenant shall be binding on myself, my heirs, successors and assigns.
