"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon; stuate, lying and being in the State of South Carolina, County of Greenville, Chick Springs." Township, being known and designated as Lot No. 43 on a plat of the subdivision known as Weelstand Melitis, property of the T.M. Wood Estate, rade by i... Brockman, Surveyor, dated october 28, 1955, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 35, at page 151, and having according to a recent survey by T.G. Adems, Engineer, the following courses and distances, to-wit:
