 - (a) A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and payable. on policies of fire and other hazard insurance covering the mortgaged pupperty, plus taxes and assessments next due on the mortgaged property (all as estimated by the Mortgaget, and of which the Mortgagor is notified) less all sums already paid therefor divided by the number of months to elapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rents, premiums, taxes and special asses
 - (b) The aggregate of the amounts payable pursuant to subparagraph (a) and those payable on the note secured hereby, shall be paid in a single payment each month, to be applied to the following items in the order
