NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$6.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements, thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bairview Township, with the following metes and bounds, to-wit:

Beginning at an iron pin on the South side of S. C. Highway No. 14, formerly U. S. Highway No. 276, said pin measuring a distance of 168 feet in a Northwesterly direction from the Northwest corner of lot of land formerly owned by Garymow property of Gault, joint corner on said Highway with other lands of H. A. Rodgers, and running thence along the said S. C. Highway No. 14, South side, in a Northwesterly direction fifty (50) feet to an iron pin, joint corner with other land of the said H. A. Rodgers; thence along the joint line of the H. A. Rodgers land in a Southwesterly direction two hundred ten (210) feet to an iron pin; thence in a Southwesterly direction along line of land of the said H. A.
