ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the Northeastern side of Pine Ridge Drive, Gantt Township, being shown and designated as Lot No. Thirty Seven (37) in Section 2, of Plat 1, on a MAP OF FRESH MEADOW FARMS MADE FOR L. A. MOSELEY AND C. HENRY BRANYON BY MADISON H. WOODWARD, R.E., MAY 21, 1945, recorded in the RMC Office of Greenville County, South Carolina, in Plat Book "S", at Page 61, reference to said plat being craved for a complete and detailed description thereof.
